BACKGROUND & SIGNIFICANCE



Lesbian, Gay, Bisexual, Transgender, Queer (LGBTQ+)

- Currently, 13.9 million adults identify as LGBT¹
- More LGBT adults live in the South than any other region¹
- >80% experienced discrimination or victimization²



Health Disparities

- Elevated risk for social isolation and loneliness
- · Poorer physical & mental health
- · Increased risk for developing cognitive impairment or dementia



LGBTQ+ Data Collection

- 2015- CMS promoting interoperability program
- Lack of data limits the ability to provide LGBTQ+ adults the care they need3




AIM



To assess the availability of data on LGBTQ+ adults (≥18 years) in South Carolina using the South Carolina Integrated Data System (SCIDS)






METHODS

- Sequential mixed methods
- Key informant interviews with Data Integration and Analysis Division at SC Revenue and Fiscal Affairs Office
- Descriptive data analysis 2000 to 2022 data for adults (≥18 years) with specific transgender ICD-9, ICD-10 codes, and DSM-5 codes



SCIDS SOURCES EXPLORED



RESULTS

- SCIDS Informant Interviews
- SOGI data not available from state agencies and organizations in the SCIDS
- Transgender adults explored with specific codes:
 - ICD-9, ICD-10, DSM-5

Key Takeaway: SOGI data is not available from state agencies in the SCIDW

SC Dept of Mental Health	Not received at the time of presentation
Medicaid	Not received at the time of presentation
State Employee Health Plan (PEBA)	Not approved
Home Health Care	33
Emergency Room Services	1045
Outpatient Surgeries	799
Hospitalizations	821

DISCUSSION

- SCIDS is robust and integral in understanding disparities and resource needs throughout South Carolina
- State agencies and organizations <u>may be</u> individually collecting SOGI
- Access to limited data from specific sources
- Lack of access to SOGI data (if collected) can lead to biased findings in disparity studies and resource needs of LGBTQ+ citizens of South Carolina
- The potential for using data for harm



CALL TO ACTION: REQUEST FOR DATA COLLECTION AND ACCESS

- Lack of fully understanding the unique needs of LGBTQ+ citizens of South Carolina.
- Recommend developing safe, protective methods of providing the option to request SOGI data if collected.

Key Recommendation:
Mandating the collection of SOGI data throughout state organizations and agencies in South Carolina to ensure appropriate care and resources are being allocated.
